16.	Entry Requirements, Access, Transfer & Progression:	The standard GMIT entry requirements for a level 8 student apply.  Transfer opportunities exist to the BA (Hons) in Outdoor Education and Geography programme.  Students who complete the BA in Outdoor Education and Leisure programme can progress to the final year of the BA (Hons) in Outdoor Education and Geography having taken the specified geography content in their programme.
17.	Programme Structure:	The programme is structured around the following themes: adventure education, teaching, safety, environment and geography, and academic and support modules. The programme includes work experience and a dissertation.

Learning, Teaching & Assessment Strategies:	The programme combines a range of pedagogic approaches appropriate to the subject and the learners including lectures, group discussions, field and laboratory practicals, active learning, and learning journals. A 'problem posing' method of teaching is utilised enabling the learner to actively engage with the module being taught.
